### **The Irwin Law Collection**

The complete list of Canadian legal publisher Irwin Law is now available from the Canadian Electronic Library in electronic form for libraries. All major titles published by Irwin from 1997 to date are included in the collection, which are available to libraries on subscription or for perpetual access ownership.

New titles or updated editions published by Irwin will be added to the collection as they appear, and subscribers will receive these as they are made available.

All titles may be licensed on a single or multiple-user basis, at the prices shown on the reverse.

Irwin joins nearly 50 Canadian publishers in all fields who are issuing their copyright materials in electronic form through Canadian Electronic Library, which makes a rich body of Canadian copyright materials available in digital form for library use for the first time ever.

- Titles are delivered to purchasers on the ebrary platform, which places little overhead demand on the library and delivers a robust fulltext search interface accessible to all authorized users.
- Full MARC records are provided for every title.
